#### Official Voting Rules

3. TABULATION OF VOTES. The total number of votes submitted during the Voting Period for the "Nominees" will be tabulated by Sponsor and the "Nominee" with the most votes, as determined by Sponsor, will be declared the winner(s). If, for any reason, this voting process is interrupted for any reason, is found to have been tampered with in any way, or for any other reason that Sponsor believes in its sole discretion to be reasonably necessary, Sponsor reserves the right to select the winners at its discretion and may take into consideration the number of votes received by a Nominee up until the time of the interruption or cancelation of the voting process.
